The criteria is on their <u>website</u>. Eligible charities and CICs can apply for up to £90,000 over three years. It supports small-to-medium-sized charities and CICs to invest in organisational development and build resilience for the future.

Funding is available over three years to support organisations that are working to build leadership skills in young people affected by racist or Islamophobic violence, empowering them to positively impact their own lives and the communities in which they live.

Application process in order:



- 1. Expression of interest email Please email first to ensure the funder and charity are a good fit.
- 2. Telephone call and visit This will be organised by the funder.
- 3. Application form Download from the website and submit before the deadline.

The Programme is intended for small organisations for whom a grant of up to £5,000 would make a significant contribution to their work. You have to be working in one of the specified geographical areas on one of the Focus Areas which are groups supporting:

- Early Years (0-5 year olds)
- Young people who experience disadvantage (social mobility)
- Young people with experience of the custody system
- Young people who experience homelessness

Grants to local groups and organisations in Elephant and Castle. Priorities for this year's grants should focus on one or more of the following key areas:

- Health and wellbeing
- Young people and training
- Communities and sustainability

In 2025 in addition to the funding on offer, applicants are also invited to apply to run their initiative from the purpose-built Community Hub space on the second floor of Castle Square free of charge.

To be eligible to apply to the Community Fund organisations must meet the following points:

- Be a not-for-profit organisation that is formally constituted (have a signed governing document in the organisation's name)
- Have good financial management procedures and a bank account
- Delivering activities that either take place within the Elephant & Castle Opportunity Area, or activities that directly benefit people who live, work or study in the area
- Be connected with and meeting the needs of the local community in and around Elephant &
  Castle Town Centre specifically the Elephant and Castle Opportunity Area

Project grants: New projects or services that will targeted at people disadvantaged as a result of long-term ill-health, disability and poverty. These are awarded to organisations with an income of £500,000 or less.

We offer single or multi year grants (up to 3 years).

Maximum grant for one year is £10,000.

Samaritan grants: a hardship fund which we make available to frontline health, social work and advice agencies to offer immediate assistance to people in an emergency. The partner agency distributes small one-off grants on our behalf.

Our grantmaking priorities are:



- Helping schools and other groups to buy equipment for the benefit of children.
- Supporting extra curricula activities for children and young people. For example, school trips, after school clubs, holiday clubs, uniformed organisations.
- Helping organisations which provide educational opportunities to schools and colleges in the Borough of Southwark. For example, visiting theatre companies and musicians.

We will usually visit organisations to ensure that the scheme is viable. However, with only £100,000 a year to give in grants, it is unlikely that we will ever fully support a project, and involvement of other grant-giving bodies is usually needed.

We are unable to guarantee continuing support to projects, and for this reason, are unwilling to take responsibility for funding the cost of salaries and administration.

You can apply for a grant only once in any 12-month period.

Small grants: The Small Grants Programme also opens twice a year – in spring and autumn with decisions made within 2-3 weeks from the closing date. Maximum £3,000. Grants for street/estate parties or similar one-off events are normally awarded a flat £1,000.

Large grants: The Large Grants Programme normally opens for applications twice a year: in spring and late summer/autumn (normally March/April and August/ September).

Large grants applications involve a two stage process, starting with a simple Expressions of Interest followed by a longer full application for shortlisted groups. There is a minimum 6 month lead-in time.

Unrestricted for groups working in Southwark alone. New strategy to launch in 2025.
